

Ride242 – Taxi Driver / Operator Terms and Conditions

Effective Date: [January 1st, 2026]

These Terms and Conditions (“Terms”) govern your access to and use of the Ride242 platform as a taxi driver or taxi operator (“Taxi”, “Driver”, “You”). By registering, accessing, or accepting ride requests through Ride242, you agree to be bound by these Terms.

If you do not agree, you must not use the platform.

1. Platform Role and Disclaimer

Ride242 is a **technology-based marketplace** operated by **Data Sphere Consulting Ltd**. Ride242 does **not** provide transportation services and does **not** operate, own, or control taxis or drivers.

Ride242 and Data Sphere Consulting Ltd act solely as intermediaries that connect independent taxi drivers with passengers.

2. Independent Contractor Status

You acknowledge and agree that:

- You are an **independent contractor**
- You are **not** an employee, agent, partner, or representative of Ride242 or Data Sphere Consulting Ltd
- You have no authority to bind Ride242 or Data Sphere Consulting Ltd in any manner

You are solely responsible for your services, conduct, vehicle, and compliance with all applicable laws and regulations.

3. Mandatory Documentation Requirements

To register and remain active on the Ride242 platform, you **must maintain and provide valid copies** of the following at all times:

- **Valid Public Service Driver’s Licence**
- **Valid Insurance Certificate or Insurance Cover Note**

- **Valid Business Licence**
- **Valid Grant Letter for a Taxi Franchise**

Failure to maintain or provide any of the above documentation may result in immediate suspension or permanent removal from the platform.

Ride242 reserves the right to verify, request updates, or revoke access at its sole discretion.

4. Taxi Driver Responsibilities

You are solely responsible for:

- Passenger safety and conduct during trips
- Vehicle condition, maintenance, and roadworthiness
- Compliance with traffic laws, transport regulations, and licensing requirements
- Setting quotes, pricing, availability, and estimated arrival times
- Any agreements formed directly with passengers

Ride242 does not supervise, control, or direct how services are performed.

5. Waiver of Liability

To the maximum extent permitted by law, you **expressly waive any and all claims** against:

- **Ride242**
- **Data Sphere Consulting Ltd**
- Their directors, officers, employees, contractors, and affiliates

for any loss, damage, injury, cost, or expense arising out of or related to:

- Your use of the Ride242 platform
- Any passenger interaction or dispute
- Accidents, injuries, property damage, or death
- Insurance claims or coverage issues
- Regulatory violations or fines

6. Indemnification

You agree to **indemnify, defend, and hold harmless** Ride242 and Data Sphere Consulting Ltd from any and all claims, demands, damages, liabilities, losses, costs, and legal fees arising from:

- Your transportation services
- Your failure to maintain valid licences, insurance, or permits
- Any injury, damage, or loss involving passengers or third parties
- Any breach of these Terms

7. Insurance Obligation

You acknowledge that Ride242 and Data Sphere Consulting Ltd **do not provide insurance coverage** of any kind for drivers, vehicles, or passengers.

You are solely responsible for maintaining adequate insurance coverage as required by law.

8. No Guarantees or Warranties

Ride242 is provided **“as is” and “as available.”**

Ride242 makes no guarantees regarding:

- Ride requests
- Passenger demand
- Earnings or availability
- Platform uptime or performance

9. Suspension and Termination

Ride242 may suspend or terminate your access to the platform at any time, with or without notice, for:

- Non-compliance with these Terms
- Missing or invalid documentation

- Complaints or safety concerns
